	I	Payment of 2018 personal income tax under the self assessment method by <u>self-employed individuals</u> not preparing audited financial statements (*).	We can estimate your income tax and assist with the payment process. Use our <u>Calculator</u> for an approximation of your income tax.
31-Jul	C & I	Electronic submission by employers of the total 2018 payroll (Form TD7).	We can assist with the completion of your IR7 and submission to Taxisnet. Use our <u>Calculator</u> to estimate your payroll costs.

	I	Electronic submission of 2018 personal income tax returns and payment of 2018 personal income tax under the self-assessment of/by employees and pensioners, whose incomes do not include income from a trade/business, rents, dividends, interest, royalties nor income relating to trading goodwill (Physical persons are required to submit personal tax returns only when their gross taxable income exceeds €19.500.)	We can assist with your personal income tax return completion and submission to Taxisnet.
01-Aug	С	Payment of 2018 final corporation tax under the self-assessment method (5% surcharge will apply if not pay by 1 September)	We can assist with the payment process for the settlement of your final corporation tax.
	I	Payment of 2018 personal income tax under the self assessment method by <u>self-employed individuals</u> preparing audited financial statements (*)	We can estimate your income tax and assist with the payment process. Use our <u>Calculator</u> for an approximation of your income tax.

A physical person is obliged to submit audited financial statements if his/her annual income from trade/business, rents, dividends interest, royalties or income relating to trading goodwill exceeds €70.000. Such physical person should be paying his/her 2018 income tax by 1 August 2019 and submitting his/her electronic tax return by 31 March 2020.
